### FEES AND REGISTRATION:

This is a two-day event; you may participate both days or only one day. Space (approximately 8 x 10) fees are as follows: one day: \$45; two days: \$55. Tables (8-feet long) are NOT included in the space fee, but are available on a limited basis for an additional charge of \$5 per table. Electricity is available on a limited basis for an additional charge of \$5 (first come/first serve). Other needs (i.e., corner, wall) may be requested, but accommodation is not guaranteed. **Registration and fees must be received by November 3, 2019.** No refunds will be made after November 3, 2019, unless you are not accepted to the Bazaar. If space permits, applications will be accepted after the November 3<sup>rd</sup> deadline.

To apply, complete the attached Registration Form and send it with a check payable to **UCNS**, along with a self-addressed stamped envelope (SASE). Confirmation and information on check-in, loading/unloading, etc., **will not** be sent to you **if a SASE is not provided** with the application. ### Eligibility and Rules:

- No food items are allowed to be sold at your table because the UCNS will have a Gourmet Table with items provided by UCNS members.
- Display racks, etc., must conform to space size. Nothing can hang from the walls or ceiling. Crafters are not permitted to change their prices during the Bazaar. Business cards displayed must pertain to the items you are selling only.
- There is **NO SMOKING** in the church hall and Fire exits are to remain unblocked at all times.
- No electrical cords may cross walkways. No children under age 12 are permitted behind display tables (exceptions may be made if asked in advance).
- Information on check-in, loading/unloading, etc., will be provided in your acceptance letter. You are responsible for the setting up/taking down your display and leaving your area clean. UCNS reserves the right to refuse the entry of any crafts deemed inappropriate. Registration and fees are considered your commitment to the Bazaar. Please refer to the first paragraph in this document for our refund policy.
- It is understood that you will not hold the Ukrainian Catholic National Shrine of the Holy Family, its Pastors, Trustees, Bazaar Committee Members, nor the Most Rev. Borys Gudziak, of the Ukrainian Catholic Archeparchy of Philadelphia responsible for any injury, property damage, or theft.
